


1. On June 20, 2003, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX-X Code Denial for the Orlando Exchange (Magnolia), along with Attachments 1 and 2. 5. Appended hereto as Attachment C is a sealed envelope containing one copy of the documents including the material which is confidential and proprietary.


