

**BELLSOUTH TELECOMMUNICATIONS, INC.'S
MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties a three (3) day extension of time or until July 25, 2003, in which to file their Rebuttal Testimony. In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on June 17, 2003, Order No. PSC-03-0718-PCO-TP, Rebuttal Testimony is due on July 22, 2003.

2. Due to the voluminous nature of the testimony filed, the expedited time schedule and other work commitments, BellSouth needs an additional three (3) days time to file its Rebuttal Testimony in the captioned docket.

3. Neither the parties nor Staff would be prejudiced by a three (3) day extension of time.

4. BellSouth contacted Supra Telecommunications and Information Systems, Inc.'s counsel and he informed BellSouth that it does not object to BellSouth's request for an extension. This three (3) day extension should apply to Supra as well.

WHEREFORE, for the foregoing reasons, BellSouth respectfully requests that the Commission grant the parties a three (3) day extension of time or until July 25, 2003 in which to file their Rebuttal Testimony.
