

AMENDMENT TO THE AGREEMENT BETWEEN MCIMETRO ACCESS TRANSMISSION SERVICES LLC AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED NOVEMBER 12, 2001

Pursuant to this Amendment, (the "Amendment"), MClmetro Access Transmission Services LLC ("MCIm"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Georgia Interconnection Agreement between the Parties dated November 12, 2001 ("Agreement") and shall be deemed effective ten (10) calendar days after the final signature on this document.

- 3. Either or both of the Parties is authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
