This is a follow up to our telephone conversation concerning your IXC and CLEC certificates, which I understand that you wish to keep both active. During our conversation, you stated that the company had no revenues during 2002. This means that the company will owe \$65.50 for each certificate (\$50.00 minimum fee, \$12.50 penalty, and \$3.00 interest). In addition, the company has a \$3.00 penalty and interest balance for late payment of the 2001 fee on its CLEC certificate.
