The Regulatory Assessment Fee (RAF) is due by January  $30^{th}$  of each year for the preceding calendar year. For certificate holders, the RAF is owed even if a telecommunications company may not have started operations or had any revenues. Since payment has not been made, statutory penalty and interest charges are now applicable.


