The Commission recently mailed out the Requests for Updated Reporting Requirements forms. The form was returned by essential.com, inc. with a hand-written note on the form, which stated "out of business." Attached was a copy of a bankruptcy "Notice of entry of order confirming plan of liquidation dated November 2, 2001." Based on this, it appears that the company has ceased operations and we believe that essential.com would no longer have any need of its certificates in Florida.

Would you please request cancellation of essential.com, inc.'s two certificates? Once we have received the request, we will initiate a docket to seek approval from our Commission for bankruptcy cancellation of essential.com's IXC and ALEC certificates. We will also request permission for the Commission to write-off the Regulatory Assessment Fees owed by essential.com, inc. However, we need your request to proceed.
