The Regulatory Assessment Fee (RAF) is due by January 30th of each year for the preceding calendar year. Any unpaid RAFs, including penalty and interest charges, are turned over to collections.

- (b) Statement of why the certificate is proposed to be cancelled.
- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
