

**AMENDED NOTICE OF APPLICATION FOR AN
EXTENSION AND DELETION OF WATER AND WASTEWATER SERVICE AREA**

Notice is hereby given on August 12, 2003, pursuant to Section 367.045, Florida Statutes, of the application of Sanlando Utilities Corporation of its intent to apply to the Florida Public Service Commission to (1) extend its service area to provide water and wastewater service to the property described below in Seminole County, Florida, and (2) delete part of its wastewater service area to discontinue providing water and wastewater service to the property described below in Seminole County, Florida. THE PURPOSE OF THE APPLICATION IS TO CLARIFY AND ESTABLISH SERVICE AREA BOUNDARY LINES. THE APPLICATION WILL NOT CHANGE EXISTING WATER AND WASTEWATER SERVICE PROVIDERS. Sanlando Utilities Corporation has amended this notice to correct certain discrepancies in the legal descriptions of the areas affected by the Application.
