COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, hereby files its Notice of Intent to Request Specified Confidential Classification.

1. In a letter dated June 16, 2003, the Florida Public Service Commission (the "Commission") requested that BellSouth provide Incumbent Local Exchange Carrier ("ILEC") data for the 2003 report on local competition. BellSouth provided information to Staff on July 31, 2003, along with a Notice of Intent for its response to Item No. 8. On August 8, 2003 BellSouth provided information to Staff in response to item Nos. 2, 3, & 4, along with a Notice of Intent. Today, BellSouth is providing responses to Item No. 1 which also contains confidential information.
