



**SUPPLEMENTAL NOTICE OF  
FUEL AND CAPACITY COST UNDER-RECOVERY**

Progress Energy Florida, Inc., formerly Florida Power Corporation, (Progress Energy or the Company) hereby supplements its Fuel and Capacity Cost Under-Recovery Notice filed July 8, 2003 to advise the Commission of the Company's decision not to request a mid-course correction at this time. Progress Energy has concluded that the earliest a mid-course correction could be implemented, cycle 1 September billings, would not provide a sufficient period over the remainder of the year to mitigate the impact of the increase on customer bills.
