1. On July 28, 2003, BellSouth Telecommunications, Inc. filed its Responses to Staff's 1st Request for Production of Documents (Nos. 1 through 4). In addition, BellSouth filed a Notice of Intent with respect to BellSouth's Response to Request for Production of Documents, Item No. 4. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification of the responses and documents provided in response to Staff's 1st Request for Production, Item No. 4 as it contains competitive business information that is considered confidential and proprietary to BellSouth. A more specific description of this information is contained in Attachment A.

3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.
