Utilities, Inc. of Florida (*UIF*), by and through its undersigned counsel, files the following Responses to Staff's Seventh Set of Interrogatories (No. 93):

- a. UIF does intend to, and has already taken, action to reduce the amount of unaccounted for water in the Lake Tarpon, Summertree, Orangewood and Golden Hills/Crownwood systems, including but not limited to, meter replacement program, leak detection survey, and main replacements in the areas of frequent repair.
- b. In the Golden Hils/Crownwood system, UIF has found and repaired a substantial leak and instituted a meter survey and replacement program. In the Orangewood, Lake Tarpon and Summertree systems, UIF has emphasized a meter survey, meter replacement program, and a service line replacement program.
- c. If the unaccounted for water percentage remains above 12% after the aforementioned programs are completed, the initiation of a water audit is intended for those systems mentioned in this Interrogatory.
