Exhibit A Description of Applicant And Request for Expedited Processing

Description of Applicant

The Applicant herein, Cable & Wireless Americas Operations, Inc. ("Applicant"), is a newly-formed company that is a wholly-owned, indirect subsidiary of Cable & Wireless plc ("CWplc"). Attached is an Organizational Chart that shows the ownership chain between Applicant and CWplc.

CWplc, based in the United Kingdom, has been providing telecommunications services directly and indirectly through its affiliates for over one hundred years on a worldwide basis. CWplc will provide the Applicant with such managerial, technical and financial support as necessary for the Application to commence operations by October 31, 2003, subject only to the grant of this Application.

Request for Expedited Processing

Applicant respectfully requests expedited processing to enable the Application to be considered at the September 16, 2003, Commission meeting. Applicant seeks to commence operations at the earliest possible time in order to serve specific customers. Applicant is a wholly owned indirect affiliate of an established, experienced carrier and an affiliate of a currently certificated AAV provider in the State of Florida, as set forth above. As set forth in Exhibit B hereto, Applicant will provide only private line and virtual private network services to business customers and will not provide local or interexchange switched service, operator ("0") or emergency ("911") services.

This Application is not intended to supercede or modify any existing Certificate of Public Convenience and Necessity ("CPCN") held by any other affiliate of CWplc in this jurisdiction. In particular, please note that Cable & Wireless USA, Inc. (CWUSA), is a separate and distinct, indirect subsidiary of CWplc.

Questions concerning this Application should be addressed solely to the contact persons for the Applicant as set forth in this Application. Questions concerning CWUSA should continue to be addressed to the contact persons of record for CWUSA.

Applicant's Organizational Chart




Exhibit B Description of Services

The Applicant will provide the following types of services:

The Applicant will provide private line and virtual private network (VPN) point-to-point and point-to-multipoint service. Such service will be provided by frame relay, asynchronous transfer mode (ATM) or Internet-based VPN (IP-VPN), depending upon customer requirements and preferences. The applicant will not provide local or interexchange switched service and will not provide operator ("O") or emergency ("911") service.

Services will be provided to:

Services will be provided to business customers.

Rates and terms for services will be set forth in:

Services will be provided under private contracts individually negotiated with customers for customized and specifically tailored service packages.

Exhibit C Proceedings Involving Affiliates

As a newly formed company, the Applicant has not been involved in disciplinary or other complaint proceedings. The Applicant is an indirect wholly owned subsidiary of Cable & Wireless plc (CWplc). Cable & Wireless USA, Inc. (CWUSA), a company currently certificated in the State of Florida as an AAV provider and elsewhere under the appropriate regulatory classification, also is an indirect subsidiary of CWplc.

The officers and directors of the Applicant are Rob Breuche, President and Director; Patricia Y. Lee, Secretary and Director; and James Palmer, Director. Patricia Lee previously served as Assistant Secretary of CWUSA.

CWplc operates on a worldwide basis and has been in operation for many years. CWUSA has operated for a number of years in the United States. The Applicant hereby provides a general overview regarding compliance issues of its US affiliate based upon such information as the applicant has been provided by that affiliate. In the event more detailed information is deemed necessary, please contact the Applicant's representative.

CWUSA settled with the Florida Office of Attorney General an Investigation regarding the marketing of broadcast facsimile services in 2002.

CWUSA has been the subject of complaints and/or investigations for unauthorized switching of a customer's long-distance service. These complaints have been resolved in cooperation with the customers affected and the relevant regulatory authority. *See In the Matter of Cable & Wireless Communications, Inc. Complaint Regarding Unauthorized Change of Subscriber's Telecommunications Carrier,* 17 FCC Rcd 21714; 2002 FCC Lexis 5756 (2002)(Customer absolved from payment for service during the first thirty days after unauthorized change occurred.)

CWUSA and/or other subsidiaries of CWplc have late-filed or failed to file various required reports from time to time, have made corrective filings, and have paid any required fine for such late filing.
