
**Application to Cancel

NOW COMES Telmatch Telecommunications, Inc. ("Telmatch") and in support of it's Application to cancel it's Certificate of Public Convenience and Necessity states the following:

1. On June 24, 1997, in Docket No. 97-0311, Telmatch was issued a Certificate of Public Convenience and Necessity ("Certificate") to provide interexchange telecommunications service as a result of a transfer of control.
2. Due to a change in the business direction of the company Telmatch no longer seeks to be a provider of interexchange telecommunications services within the State of Florida.
3. Telmatch has no customers in the State of Florida. As a result, cancellation of Telmatch's Certificate is reasonable and would not be unduly disruptive to the present or future public convenience.
