The FCC's Triennial Review Order, which was released on August 21, 2003, provides, among other matters, that a state commission may if it chooses rebut the FCC's presumption that a CLEC is not impaired absent access to unbundled local circuit switching to serve enterprise customers who receive network access with DS1 or higher capacity loops; a state commission that chooses to rebut this presumption has 90 days from the effective date of the FCC's order to do so. Given the short time frame afforded by the FCC, staff wishes to file a recommendation concerning how we believe the Commission should proceed on this matter. Staff proposes to file a recommendation no later than 3 p.m. on Monday, August 25, 2003.
