





Utilities, Inc. of Florida ("UIF") has filed an Application with the Florida Public Service Commission to revise its service availability charges in its Lincoln Heights/Ravenna Park service area. These increased charges are to reflect the charge which is being imposed by the City of Sanford which provides treatment and disposal services in that service area and will be paid by new, not existing customers.

A comparison of the present and proposed rates are as follows:

Present	- \$200.00 per single family equivalent
Proposed	- \$2,125.00 per single family equivalent
