

**BELLSOUTH TELECOMMUNICATIONS, INC.'S
MOTION FOR EMERGENCY PARTIAL CONTINUANCE**

Now comes, BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.210, Florida Administrative Code, and moves for an Emergency Partial Continuance of the above captioned matter. Specifically, BellSouth states:

1. The above captioned matter is scheduled for hearing on August 29, 2003.
2. One of BellSouth's witnesses, John Ruscilli, has learned that his father-in-law died this morning in Helena, Alabama. Mr. Ruscilli will not be available for the hearing due to this emergency.
3. It is crucial to BellSouth's case to have the testimony of Mr. Ruscilli presented live. There are matters upon which Mr. Ruscilli must present testimony that are not included in his prefiled testimony. See the August 27, 2003 letter from Nancy White to Blanca Bayó, filed in this docket.
4. For this reason, BellSouth requests that a partial continuance, specifically that the hearing go forward on August 29, 2003 with the exception of Mr. Ruscilli. Mr. Ruscilli would be continued to the first day available at the Commission's convenience.
5. Supra's counsel has indicated that it would object to such a continuance.

Wherefore, BellSouth respectfully request that the Commission grant this Motion for Emergency Partial Continuance.
