Staff requests permission to make an oral modification to its recommendation for Docket No. 020010-WS, which the Commission will take up as Item No. 8 on the September 2, 2003, Agenda Conference.

The changes staff requests are shown below in legislative format:

On the cover page, add a second docket, after the first docket number, but before the County designation, which reads:

DOCKET NO. 990374-WS - APPLICATION FOR CERTIFICATES TO OPERATE A WATER AND WASTEWATER UTILITY IN HIGHLANDS COUNTY BY THE WOODLANDS OF LAKE PLACID, L.P., AND FOR DELETION OF PORTION OF WASTEWATER TERRITORY IN CERTIFICATE NO. 361-S HELD BY HIGHLANDS UTILITIES CORPORATION.

On Page 32, the Close the Docket issue should be changed as follows:

ISSUE 13: Should ~~this docket~~ these dockets be closed?

RECOMMENDATION: Upon the expiration of the appeal period, if no party timely appeals the order, upon staff's verification that the utility has completed the required refunds and upon the filing and staff's approval of the revised tariff sheets, ~~this docket~~ these dockets should be closed administratively.
