

ORDER GRANTING APPLICATION BY I DEBTOR TO EMPLOY GRONEK & LATHAM, LLP, NUNC PRO TUNC TO JULY 165, 2003, AND FOR AUTHORITY TO PAY \$35,000 RETAINER AND AUTHORIZIING WITHDRAWAL OF JAMES E. FOSTER AND AKERMAN SENTERFITTT, AS DEBTOR'S COUNSEL

- The Debtor is authorized to disburse \$35,000 to G&L as a retainer against which G&L cann bill, subject to review and approval by this Court upon propper application in accordance with 11 U.S.C. § 330.
- During the pendency obf the case, any unearned retainer shall be held in a trust accountt.
- Until further order obf the Court, G&L may bill against the retainer on a monthly basiss for 100% of its costs and for 70% of its fees as they accrue withhout further order, but subject to final review and approval by thhe Court.
- This Order is without prejudice to G&L requesting, by subsequent application or motion, additional payment of fees and expenses.
- James E. Foster and AAkerman Senterfitt are hereby relieved of any further responssibility in this case.
