Cargill Fertilizer, Inc. (Cargill), pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification.

1. On September 3, 2003, Cargill filed the testimony and exhibits of Gerard J. Kordecki and Roger F. Fernandez. Mr. Kordecki's testimony contains Tampa Electric Company (TECo) confidential information at page 3, l. 12; page 22, l. 5, and 12; page 25, l. 6, 20, 22. Mr. Kordecki's exhibits contain TECo confidential information at GJK-1, GJK-2, GJK-3, and GJK-4. Mr. Fernandez's testimony contains confidential information at page 6, l. 23 and page 7, l. 3, 11, and 12. 
