T-NETIX Internet Services, Inc. received its Certificate to operate as an interexchange telecommunications service company in **Docket No. 001490-TI, Order No. PSC-01-0014-PAA-TI and Consummating Order Number PSC-01-0247-CO-TI, effective January 26, 2001.**

The Company has never operated in Florida and therefore there will be no customer impact associated with approval of this filing. In support of this request, the Company states the following:
