NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION
OF CERTAIN INFORMATION**

Teleport Communications Group Inc. and TCG South Florida (collectively, "TCG") pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, hereby file this Notice of Intent to Request Specified Confidential Classification and state the following:

1. On July 18, 2003, Verizon Florida Inc. ("Verizon") filed its Petition and exhibits in this docket. By letter dated July 17, 2003, Verizon requested confidential treatment of the entire petition as well as the attached exhibits.

2. TCG filed its Motion to Dismiss the petition on August 6, 2003. Although TCG objected to Verizon's classification of its entire filing as confidential, TCG filed its Motion under confidential cover in order to provide Verizon the opportunity to claim confidentiality with regard to the information therein. On August 25, 2003, Verizon filed its Opposition to TCG's motion under confidential cover.

3. Portions of the above filings contain proprietary confidential business information. Pursuant to direction by Commission staff, the parties have agreed to refile their pleadings after redacting information that either party considers confidential. TCG has filed its redacted Motion to Dismiss and anticipates that Verizon will refile its Petition and Opposition in the near future.
