NOTICE OF HEARING TO CONSIDER APPROVAL OF DISCLOSURE STATEMENT

1. On September 13, 2003, the debtors and debtors in possession in the above-captioned chapter 11 case (the "Debtors") filed with the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") their Joint Plan of Reorganization (the "Plan") and the accompanying Disclosure Statement Pursuant to Section 1125 of the Bankruptcy Code with respect to the Debtors' Joint Plan of Reorganization (the "Disclosure Statement"). The Debtors intend to present the Disclosure Statement and any changes or modifications thereto for approval at a hearing before the Honorable Peter J. Objections, if any, to approval of the Disclosure Statement must be in writing and shall (i) state the name and address of the objector or entity proposing a modification to the Disclosure Statement and the amount of its claim or nature of its interest in the Debtors' chapter 11 case; (ii) specify the basis and nature of any objection or proposed modification together with suggested language, if any, and (iii) be filed with the Bankruptcy Court, 3rd Floor, 824 Market Street, Wilmington, Delaware 19801 together with proof of service, and served so as to be RECEIVED on or before 4:00 p.m. prevailing Eastern Time on October 8, 2003 (the "Objection Deadline") by (i) counsel to the Debtors, Young Conaway Stargatt & Taylor, LLP, The Brandywine Building, 1000 West Street, 17th Floor, Wilmington, Delaware 19801 (Attn: Pauline K. 
