Dear Ms. Bayó:

This correspondence proposes a settlement offer in the above-referenced docket. Winstar Communications, LLC (Winstar) proposes this settlement in order to remain a certified competitive local exchange carrier in Florida. Winstar had paid its 2002 RAF and the associated interest due. Enclosed please find a copy of the 2002 RAF invoice which shows that Winstar paid the amount due in full, plus a copy of Winstar's check in the amount of \$18.21 which was sent to the Commission on September 4, 2003 in payment of the interest due on the account.

Winstar's ultimate parent, IDT Corporation, purchased the assets of a bankrupt telecommunications carrier and created Winstar to operate those assets. Winstar, in its first year of operation, has endeavored to integrate its financial reporting and other systems with its parent company. Additionally, Winstar operates on a fiscal year basis (year ending July 31). Therefore, the calendar year data necessary for its 2002 RAF filing was unavailable on the January 30, 2003 due date. Winstar understands the importance of regulatory compliance, and intends to meet its annual reporting requirements in the future in a timely manner.

Winstar agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer.

Winstar proposes a \$100 settlement in order to resolve the matter in the above-mentioned docket.


