Dear Ms. Bayó:

On August 5, 2003, Florida Power & Light Company ("FPL") filed its Petition for Approval of Florida Power & Light Company's Green Power Pricing Research Project ("Petition"). This Petition has been assigned Docket No. 030752-EI.

As part of its Petition, FPL sought approval of new tariff sheets implementing its Green Power Pricing Research Project. Absent the Commission withholding consent of those tariff sheets, these tariff sheets will become effective 60 days after they were filed with the Commission. Section 366.06(3), Florida Statutes.

The Commission has not withheld consent to FPL's Green Power Pricing Research Project tariff sheets, and the matter is not scheduled for Commission consideration until after the expiration of 60 days. The Commission Staff has requested FPL to waive its statutory entitlement to charge these new tariff sheets in the absence of the Commission withholding consent so that this matter can be considered by the Commission at its regularly scheduled Agenda Conference on October 21 or November 4, 2003. There are no entities that have sought to intervene.

In consideration of the Commission Staff's request, FPL is filing this letter waiving, for an additional 34 days, through November 7, 2003, its statutory privilege to implement these new tariff sheets if the Commission does not act to suspend them within 60 days of their filing. In doing so, it is FPL's understanding that the Commission may act before November 7, 2003 on FPL's Petition and that such action could include a suspension of the tariff sheets or their


