Dear Commissioners:

The purpose of this letter is for the Florida Cable Telecommunications Association, Inc. (FCTA) and the Southeastern Competitive Carriers Association (SECCA) to comment briefly on BellSouth's new tariff offering, which, on an integrated basis, converts a VoIP signal to a format readily transportable on the public switched telephone network and transports such traffic on BellSouth's network. The FCTA and SECCA did not seek to oppose this tariff or suspend its operation. However, we would like to note that, given the non-traditional functionalities provided by this tariff, we do not believe the Commission should view the effectiveness of this tariff, the fact that it was filed within BellSouth's broader "access" tariff, or the particular rates included in it, as particularly relevant to the broader question of whether VoIP offerings should be subject to access charges as traditionally conceived and, if so, under what circumstances and at what rates.
