The Docket Number in this matter is 030733-TC, scheduled to be addressed before the Commission on September 30, 2003.

Colony 14 Communications, Inc. believed that it had returned the Regulatory Assessment Form and Fees for the calendar year 2002. This matter is currently being researched. However, in the interest of resolving this matter, and in an attempt to avoid the cancellation of our Certificate, we are enclosing check number 1056 in the amount of \$66.50. This payment includes the \$50.00 RAF fee for the calendar year 2002, including the \$12.50 penalty fee assessment and the \$4.00 interest fee.

Colony 14 Communications, Inc. believed that this matter had been taken care of in the regular course of business. We have already taken steps to ensure timely payment of our Regulatory Assessment Fee in the future.
