



**FL Legislation Rebalancing Refiling
Errata Description
Jerry Hendrix Testimony Revisions**

Three basic changes were made to Jerry Hendrix's testimony:

1. The plan was modified to include three access rate decreases in increments of 40/35/25 percent.
2. The beginning of each year of the rebalancing period is changed from Jan. 1 to 1QXX.
3. Clarification to paragraph of Page 6 was made to describe how the access reductions are to be taken.

year of both methodologies, terminating CCL will be eliminated and the remainder of the reduction will be taken in local switching. Exhibit JH-3....

To: "...quarter, 2004 (1Q04), the second reduction during the first quarter, 2005 (1Q05),

and the third reduction during the first quarter, 2006 (1Q06). The proposed

reductions will be taken in the following manner:

1Q04 – 40 percent

1Q05 – 35 percent

1Q06 – 25 percent

For both methodologies proposed by BellSouth, implementation of the 1Q04 reduction will eliminate originating Carrier Common Line (CCL) revenues and reduce terminating CCL revenues. For both methodologies again, the 1Q05 reduction will eliminate terminating CCL revenues and reduce local switching revenues. For both methodologies again, the 1Q06 reduction will be taken in local switching revenues. Revised Exhibit JH-3..."

John Ruscilli's Direct Testimony and Exhibit JAR-1 were revised to reflect the following significant changes:

- Residential rate increases and nonrecurring charge increases over three increments in not less than twenty-four (24) months effective 1Q04, 1Q05 and 1Q06 versus rate changes in two equal increments effective January 1, 2004 and January 1, 2005. Business (1FB) adjustments will be in two equal increments effective 1Q04 and 1Q05.
- Switched Access revenue reductions will be done in three increments of 40%, 35% and 25% effective 1Q04, 1Q05 and 1Q06, respectively.

Changes to the Testimony of E. Steven Bigelow

Two corrections were made to Exhibits SB-1 and SB-2. First, the historical demand for flat rate single line business lines was revised to correct for an error in the database. This correction resulted in a reduction of approximately \$940,000 in the proposed annual revenue change. Second, the annual historical demand for flat rate residence lines was reduced by 414 lines. This correction properly accounted for lifeline customers in the Century exchange and resulted in a reduction of approximately \$1,450 in the proposed annual revenue change.

To maintain a revenue neutral filing, these reductions were offset through additional increases in the proposed A4 service order charges.

Changes to Dr. Gordon's Testimony

1. On Page 6 Line 10, two new Q&As have been added:

Q. YOU HAVE NOTED IN YOUR MAJOR CONCLUSIONS THAT VERIZON FLORIDA INC., BELLSOUTH TELECOMMUNICATIONS, INC., AND SPRINT-FLORIDA INC. HAVE REVISED THEIR RESPECTIVE RATE REBALANCING PLANS FILED ON AUGUST 27, 2003 TO EXTEND THE TIME OVER WHICH INTRASTATE NETWORK ACCESS AND BASIC LOCAL TELECOMMUNICATIONS RATES WILL BE REFORMED. HAVE YOU REVIEWED THESE COMPANIES' REVISED PLANS?

A. Yes, I have.

Q. DO THESE REVISIONS AFFECT YOUR ANALYSIS OF THE COMPANIES' PLANS OR YOUR TESTIMONY?

A. No. With the exception of the minor changes — changing “plans” to “revised plans” — as well as this and the previous question and answer, my testimony remains unchanged from the testimony that I filed on August 27, 2003.
