**XO FLORIDA, INC.'S MOTION FOR EXTENSION OF ORDERS  
GRANTING CONFIDENTIAL CLASSIFICATION**

XO Florida, Inc. (XO), pursuant to Rule 25-22.006, Florida Administrative Code, files this Motion for Extension of Orders Granting Confidential Classification.

1. On May 1, 2002, the Commission issued Order No. PSC-02-0598-CFO-TP<sup>1</sup> granting XO's request for confidential treatment of Document No. 03761-02. On May 15, 2002, the Commission issued Order No. PSC-02-0666-CFO-TP granting XO's request for confidential treatment of Document No. 04232-02. Both orders provided that confidential treatment of the documents would expire 18 months after the date of the issuance of the orders in the absence of a renewed request for confidentiality.


2. The reasons XO asserted in support of confidential treatment in its requests for specified confidential classification of Document Nos. 03761-02 and 04232-02 continue to pertain. Specifically, disclosure of the proprietary confidential business information contained in those documents would harm XO's competitive interests.

3. For the reasons set forth above and in XO's original requests for specified confidential classification, XO hereby requests that the Commission enter an order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain in the Commission's possession.


