

**NOTICE OF APPLICATION FOR AN
EXTENSION OF WATER SERVICE AREA**

Notice is hereby given on October 7, 2003, pursuant to Section 367.045, Florida Statutes, of the Application of Utilities, Inc. of Florida ("UIF") of its intent to apply to the Florida Public Service Commission to extend its service area to provide water service to the property described below in Seminole County, Florida. THE PURPOSE OF THIS APPLICATION IS TO AMEND THE LEGAL DESCRIPTION IN UIF'S WATER CERTIFICATE ON FILE WITH THE FLORIDA PUBLIC SERVICE COMMISSION TO REFLECT THE ACTUAL AREA CURRENTLY BEING SERVED BY UIF. THE APPLICATION WILL NOT CHANGE EXISTING WATER SERVICE PROVIDERS.
