This letter is to inquire about the status of the complaint noted above. Based on your last telephone conversation with Commission staff, we are under the impression that Hurricane Hole Marina and K W Resort Utilities Corp. were able to reach a compromise which resulted in an executed Utility Agreement and successful connection to the K W Resort Utilities Corp. collection system.

If Hurricane Hole Marina is satisfied with the execution of the Utility Agreement, we request that you notify the Commission in writing and withdraw your complaint. However, if your concerns regarding capacity reservation fees still exist, please provide staff with specific areas of concern in writing no later than November 3, 2003. Information received after this date may not be considered in staff's recommendation in this docket to go before the Commission on December 16, 2003.
