
DIECA COMMUNICATIONS INC., D/B/A COVAD COMMUNICATIONS COMPANY'S, NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION

DIECA Communications, Inc., d/b/a Covad Communications Company (Covad), pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification.

1. On September 24, 2003, Covad filed its Complaint Against BellSouth Telecommunications, Inc. for Breach of the Parties' Interconnection Agreement and Sections 271 and 251 of the Telecommunications Action of 1996, Request for Maintenance of Status Quo, and Request for Expedited Relief. Attached here to is Revised Exhibit A to the Complaint which contains confidential customer information. Section 364.24, Florida Statutes, prohibits the public disclosure of customer account information. Further, Covad considers the information in Revised Exhibit A to be confidential proprietary business information.

2. Because Revised Exhibit A contains information which Florida law prohibits public disclosure of, and which Covad claims to be confidential and proprietary to Covad, Covad files this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of Revised Exhibit A without delay. Covad will file a Request for Confidential Classification in accordance with the applicable Commission rules. The original of this Notice has been filed

with the Division of Records and Reporting, and a copy has been served on all parties of record.


