

INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, hereby files its Notice of Intent to Request Specified Confidential Classification.

1. In a letter dated June 16, 2003, the Florida Public Service Commission (the "Commission") requested that BellSouth provide Incumbent Local Exchange Carrier ("ILEC") data for the 2003 report on local competition. BellSouth provided certain information to Staff on July 31, 2003, August 8, 2003, August 11, 2003, August 13, 2003, August 14, 2003, August 18, 2003, August 21, 2003 and August 28, 2003. Today, BellSouth is providing its supplemental response regarding the Century Exchange, which also contains confidential information.

2.
