Granite Telecommunications, LLC, by its regulatory consultants and pursuant to Florida Public Service Commission ("Commission") Order No. PSC-03-0896-PCO-TP in the above-referenced proceeding, hereby verifies that it would have sought implementation of the rates ordered in this proceeding absent the Commission's August 5, 2003 grant of Verizon's Motion to Stay the effectiveness of Order No. PSC-01-1574-FOF-TP pending judicial review.

Commission Order No. PSC-03-0896-PCO-TP, in which it granted Verizon's Motion to Stay, at page 9 states:

To be eligible for the full aforementioned refund back to the date of this Order, a CLEC must, within 90 days of the issuance of this Order, file with the Commission and send to Verizon a letter stating that the CLEC would have sought implementation of the rates ordered in this proceeding, absent the stay. This condition recognizes the varying effect of the rates on individual CLECs. Any CLECs that submit the required letter after the 90 days will only be eligible for a refund back to the filing date of their letter.


