Dear Mrs. Bayo:

The undersigned carriers, AT&T Communications of the Southern States, LLC ("AT&T"), MCImetro Access Telecommunications Services, LLC ("MCI") and DIECA Communications, Inc. d/b/a Covad Communications Company ("CLEC Coalition") submit this letter in response to the Staff's Memorandum dated October 2, 2003, in this docket, soliciting comments for the Six Month Review of Sprint's Florida Performance Measurement Plan and Sprint's proposal to adopt in Florida the revisions to Sprint's Nevada Performance Measurement Plan as adopted by the Nevada Public Service Commission. Sprint filed proposed revisions to its performance measurement standards, based on those adopted by the Nevada Public Utilities Commission, and seeks their implementation in Florida on the same dates as planned in Nevada (February 20, 2004 for all revisions except the DS1 and DS3 disaggregation would be effective October 20, 2004).

The CLEC Coalition appreciates the opportunity to review the proposed changes and provide comments before the Staff recommendation on whether to implement the Nevada changes in its Florida performance measures. Our review of Sprint's proposed changes determined that we have some concerns about the revisions. In addition, we have some concerns about Sprint's current Florida Performance Measurement Plan. However, given the many



regulatory issues before the Commission at this time, especially the Triennial Review Order cases, we submit that an extensive review of Sprint's performance measures at this time is not the best use of the parties' and Commission's limited resources. Without waiving its objections to the proposed revisions, the CLEC Coalition therefore requests that the Commission allow Sprint's proposed revisions to take effect as scheduled, subject to a more extensive consideration in the six-month review process. This would provide for a full review of the measures at a more appropriate time, without prejudicing any of the parties.


