Dear Ms. Bayó:

On August 5, 2003, Florida Power & Light Company ("FPL") filed its Petition for Approval of Florida Power & Light Company's Green Power Pricing Research Project ("Petition"). This Petition has been assigned Docket No. 030752-EI. As part of its Petition, FPL sought approval of new tariff sheets implementing its Green Power Pricing Research Project.

On September 22, 2003, at the request of the Commission Staff, FPL waived for 34 days through November 7, 2003, its statutory privilege, pursuant to Section 366.06(3), Florida Statutes, to implement these new tariff sheets if the Commission did not act to suspend them within 60 days of their filing.

By means of this letter, FPL is further waiving its statutory privilege to implement these new tariff sheets. FPL agrees to waive its statutory privilege to implement these tariff sheets an additional 27 days through December 4, 2003. This additional waiver should allow the Commission to consider these tariff sheets at its December 2, 2003 Agenda Conference without having to act to suspend them. Absent Commission action on or before December 4, 2003, it is FPL's understanding that the tariff sheets will become effective December 5, 2003.


