**DIECA Communications, Inc. d/b/a Covad Communications Company's  
Motion for Extension of Time to File Interconnection Agreement**

DIECA Communications, Inc. d/b/a Covad Communications Company (Covad), pursuant to rule 28-106.204, Florida Administrative Code, file this Motion for Extension of Time to File Interconnection Agreement. As grounds therefore, Covad states:

1. On October 13, 2003, the Commission entered its Order No. PSC-03-1139-FOF-TP in the above docket and directed the parties to file an Interconnection Agreement within 30 days of the Order, making the final Interconnection Agreement due on November 12, 2003.

2. Covad requests an extension of time to file the final Agreement for two reasons. First, the parties have worked diligently to comply with the deadline established in the Commission's Order, the parties have not yet reached agreement on language implementing all of the determinations in that Order and do not anticipate being able to do so by November 12, 2003. The additional time requested would permit the parties to finish drafting and finalize such language.

3. Second, on October 28, 2003, Covad filed a Motion for Reconsideration regarding one aspect of the Commission's decision. Economy and efficiency would be served if the Commission's decision on the Motion, which is scheduled for release on December 23, 2003, could be incorporated into the final Agreement submitted for approval.



4. Thus, Covad requests that the Commission permit the parties to file their Interconnection Agreement 21 days after the entry of the Commission's Order on Reconsideration.
