PROGRESS REPORT

Pursuant to Order No. PSC-03-0889-PCO-SU issued August 4, 2003 in Docket Nos. 981079-SU, and 020254-SU, Hudson Utilities, Inc. ("Hudson") hereby files its October Monthly Report addressing the progress of construction of the sewers and other wastewater infrastructure in the Signal Cove service area.

1. In Order No. PSC-03-0889-PCO-SU, the Florida Public Service Commission ("Commission") granted Hudson's Motion for Extension of Time to file proof of the transfer of the Signal Cove service territory from Pasco County to Hudson. In the Order, the Commission stated:

Hudson shall file monthly progress reports in Docket No. 020254-SU, listing total expenses to date, anticipated remaining expenses, and an estimated date to complete construction to Signal Cove. The first monthly progress report shall be due on September 11, 2003. Order, pages 14-15.

2. Hudson has secured the financing necessary to complete the construction to the Signal Cove service territory. On June 23, 2003, Hudson filed with the Commission in the instant docket a copy of the fully executed Commitment Letter relating to the loan, dated June 17, 2003, and the Term Sheet guaranteeing the terms of the loans. On August 20, 2003, Hudson filed a Notice of Loan Closing regarding financing necessary to complete the Signal Cove construction project and an Affidavit advising the Commission that on August 11, 2003, Hudson closed in the above loan upon

the terms and conditions contained in the Commitment Letter and Term Sheet previously filed with the Commission.

3. Hudson maintains its commitment to service the Signal Cove service territory as soon as possible and timely commenced construction of the project upon the closing of the loans. The construction project has proceeded in a timely manner subject only to some delays due to inclement weather. In response to the Commission's specific request in Order No. 03-0889-PCO-SU, Hudson submits the following:

a. Total expenses to date

Response: As of November 5, 2003, Hudson has expended \$274,030.00 on the construction of the Signal Cove project.

b. Anticipated Remaining Expenses

Response: As of November 5, 2003, Hudson estimates the remaining expenses for the project to be \$409,253.00.

c. Estimated Date to Complete Construction to Signal Cove

Response: Hudson estimates that the Signal Cove construction project will be completed on January 31, 2004.


