Jackie, the letter notifies the Commission of a name change on its IXC and CLEC certificates (TJ257 and TX317) from Metromedia Fiber Network Services, Inc. to AboveNet Communications, Inc. The letter (last paragraph) states that "It is our understanding that formal Commission approval is not required in this matter." I thought it was required -- name change docket. Anyway, this is your call. However, TJ257 owes \$3 P&I for late payment of the 1999 RAF and has not paid the 2002 RAF, penalty and interest. I did not open a RAF docket against them because of the bankruptcy. TX317 only owes \$3 P&I for late payment of the 1999 RAF (they paid the 2002 RAF). Both, of course, will owe the 2003 RAF but it is not due until January 30, 2004.

Ruth, as information, Metromedia is marked as having filed for bankruptcy in 2002. In the 2002 undocketed file, there are three documents and in 2003 undocketed file, there are three:
