By letter dated October 7, 2003, Peoples Gas System ("Peoples" or the "Company"), pursuant to the request of the Commission Staff, waived the 60-day requirement for Commission action on the Company's tariff filing in the above docket (under the file-and-suspend statute), subject to the Commission's taking action on such tariff filing at its December 2, 2003 agenda conference. Peoples has now been advised by Staff that its filing in the above docket will be moved from the December 2 agenda conference to the December 16 agenda conference.


