Dear Mr. Meimoun:

Docket No. 030776-TI was established on August 7, 2003, for nonpayment of the 2002 Regulatory Assessment Fee. On August 12, 2003, the Commission received a check from the company in the amount of \$191.43 with a copy of the company's 2000 Regulatory Assessment Fee return. I attempted to call you on August 13th, but a recording advised your voice mail was full, so I could not leave a message. I later faxed you a note explaining the above and asked for a call back. As of this date, I have not heard from you.

Although a check was received (the payment was applied to the 2002 fee), the company has not complied with the Regulatory Assessment Fee statute by completing the 2002 return showing 2002 revenues (unless 2002 revenues are the exact same as the year 2000) nor has the company proposed a settlement to resolve this docket. Based on the above, it is staff's intention to go forward with recommending a fine of \$1,000 since this is the second docket for the same rule violation.

Therefore, if the company wishes to keep its certificate active and in order to resolve this docket, the company must:

- Complete and send in the 2002 Regulatory Assessment Fee return; and
- Propose a settlement in lieu of the \$1,000 fine.

Please review this information and respond by December 7, 2003. If a response is not received by December 7th, staff will have no choice except to go forward with its recommendation to fine Executive Business Centers, Inc. \$1,000.
