Specific confidentiality pertains to FPSC Staff High-Capacity Loop Questions, FCC Rules, Section 51.319(a)(4), (5) and (6) Customer Information, Street Address of customer served by high-capacity loop (column A). It is our belief that public disclosure of DayStar customer addresses will infringe on customer confidentiality and hinder DayStar's competitive position in the market.

Materials enclosed pursuant to this confidentiality request include one unedited hardcopy of the loop\_DayStar Communications\_FL Spreadsheet, one hardcopy with the specific confidential information highlighted, and two edited hardcopies of the confidential information marked out for public inspection.

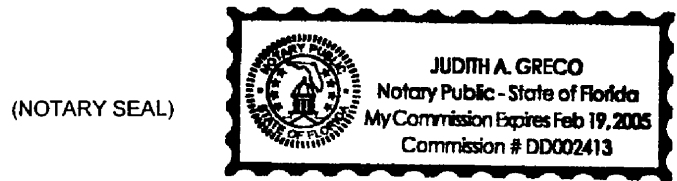
