
Delta Phones, Inc. understands that just paying the past due amount will not prevent our certificate from being cancelled.

Dear Mr. Stolberg:

On October 6, 2003, the Commission received your letter dated September 30th proposing a settlement to resolve Docket No. 030629-TX. The last sentence of your proposal, copy attached, states "Delta Phones, Inc. is requesting a settlement in the sum of." An amount was not listed. On October 9, 2003, I called Rhonda Walters and brought the above to her attention. Ms. Walters advised me that she would have the company complete the sentence with an amount and resend the settlement proposal. As of this date, the Commission has not received the amended settlement.

The company has two options at this point. The first is to amend your settlement proposal to include an amount. In other similar cases, the Commission has accepted settlements between \$100 and \$500 in lieu of the \$500 fine normally imposed for this rule violation. The second option is for staff to recommend that your settlement offer be denied and to impose a \$500 fine.

Please review this information and respond by December 7, 2003. If a response is not received by December 17th, staff will have no choice except to go forward with its recommendation to fine Delta \$500. If you have any questions, just let me know.
