SECTION 3 - DESCRIPTION OF SERVICES

3.15 GE Residential Services

GE Residential Long Distance is a long distance Service offered to Residential Customers and includes direct dial long distance, TFS, calling card, and directory assistance. This Service is limited to those Customers who subscribe to the companion interstate Service. Except for the intrastate usage rates set forth in Section 4 herein, these Services are subject to the rates, terms, and conditions for interstate Service. Calls are billed in initial and additional one minute increments. Option 1 is available only to Customers who subscribe to this Service via the Internet. Payment via a Company approved Credit Card is required. Call detail is provided to the Customer monthly. Option 2 is available to all Residential Customers who bill a minimum of \$10.00 in long distance usage each month excluding monthly recurring charges. If a Customer bills less than the minimum in any month, a monthly fee will be charged as set forth in Section 4. Payment via a Company approved credit card is required. The Customer has the option of receiving a paper or an electronic bill.
