Global Crossing Ltd. and GC Acquisition Limited, by their attorneys, notify the Florida Public Service Commission that the transfer of control of Global Crossing Ltd.'s Florida operating subsidiaries to GC Acquisition Limited was completed effective December 9, 2003.<sup>1</sup>

In connection with the consummation of the transaction, GC Acquisition Limited has changed its name to Global Crossing Limited.<sup>2</sup> The names of the Florida operating subsidiaries remain the same.


