BellSouth Telecommunications, Inc. ("BellSouth") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, this Request For Specified Confidential Classification and states the following:

1. On December 1, 2003, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Cocoa Beach Exchange, along with Attachments 1, 2 and 3. Attachments 1 and 3 contain information that is considered confidential and proprietary to BellSouth. A Notice of Intent to Request Specified Confidential Classification for these attachments was also filed on the same day.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for Attachments 1 and 3 because said attachments contain switch utilization information and customer information that is considered confidential and proprietary to BellSouth. A more specific description of this information is contained in Attachment A.
