**AT&T'S REQUEST FOR EXTENSION OF TIME
TO FILE RESPONSE TO BELL SOUTH'S AMENDED
MOTION TO MODIFY SEEM PLAN AND
REQUEST TO OFFSET OR ESCROW PENALTY PLANS**

AT&T Communications of the Southern States, LLC (hereinafter "AT&T"), by and through undersigned counsel, pursuant to Rule 28-106.204, Florida Administrative Code, respectfully moves the Commission for an extension of time to file its Response to BellSouth Telecommunications Inc.'s (hereinafter "BellSouth") Amended Motion to Modify SEEM Plan and Request to Offset or Escrow Penalty Plans, filed on December 18, 2003. In support of its Motion, AT&T states:

1. BellSouth filed its Amended Motion to Modify SEEM Plan and Request to Offset or Escrow Penalty Plans on December 18, 2003.
2. BellSouth served the Amended Motion on AT&T by U.S. Mail on December 18, 2003. AT&T actually received the Amended Motion on December 22, 2003. Pursuant to Florida Administrative Code, AT&T has only seven (7) calendar days plus five (5) calendar days for mailing to file its response to BellSouth's Amended Motion.
3. AT&T's counsel and subject matter experts have substantial work and travel conflicts over the next two weeks. This coupled with the reduced availability of needed personnel during


the holidays, AT&T requires additional time to prepare AT&T's response to BellSouth's Amended Motion.

4. Therefore, AT&T requests an extension of time to file its response to BellSouth's Amended Motion until January 8, 2004.

5. Since there are no Commission proceedings currently scheduled in this docket, there would be no prejudice to any party in granting the delay.

WHEREFORE, based on the foregoing, AT&T requests that the Commission grant AT&T an extension of time, until January 8, 2004, to file its response to BellSouth's Amended Motion.


