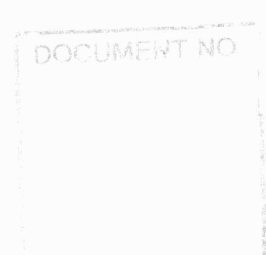

Kay/Hong,

The above two dockets were filed as amendments but were in actuality adoptions. BellSouth has filed a correction letter for each agreement and I am preparing the "corrected" memo's. Is there a specific format you would prefer I use?

Below is text of one of the memo's. I would appreciate your thoughts on whether it meets our needs for correcting the "close memo's".

"By letter dated October 2, 2003, BellSouth Telecommunications, Inc. filed a correction in this docket. This correction indicates the docket title should be revised from an amendment to the interconnection, unbundling, resale, and collocation agreement to an adoption of existing interconnection, unbundling, resale, and collocation agreement. The underlying agreement between BellSouth and MCImetro Access Transmission Services LLC was approved by the Commission in Docket No. 000649-TP. NOS Communications, Inc. d/b/a International Plus d/b/a 011 Communications d/b/a The Internet Business Association d/b/a I Vantage Network Solutions is adopting the interconnection, unbundling, resale, and collocation agreement approved by the Commission pursuant to Section 252(i) of the Telecommunications Act of 1996.

Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(i) requires that a local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved by the state commission to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety.

The filing met the criteria outlined in Section 2.07.C.15 of the Administrative Procedures Manual in that it complies with Section 252(i) of the Act. This docket was closed previously by Memorandum dated September 19, 2003."
