CLEC Certificate No. 6056 was granted to Hyperion Communications of Florida, LLC by Order No. PSC-99-0556-FOF-TX effective 4/17/99. The company's name was subsequently changed to Adelpia Business Solutions of Florida, LLC by Order PSC-99-2172-FOF-TP, effective 11/18/99.

CLEC Certificate No. 6065 (as referenced on Tommy's request to establish docket and subsequent e-mail) was granted to ComScape Communications (Company Code TX281) by Order No. PSC-99-0556-FOF-TX, effective 4/17/99. Certificate No. 6065 was canceled by Order PSC-02-0275-PAA-TX and PSC-02-0417-CO-TX, effective 11/19/01 pursuant to the company's request for voluntary cancellation.

Based on the above information, the new docket to acknowledge Adelpia's request for name change on its CLEC certificate should reflect Certificate No. 6056.

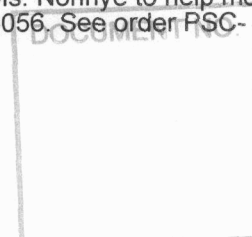
