NOTICE OF CHANGE

Notice is hereby given that the following changes have been made to the proposed rule 25-30.445, F.A.C., in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 29, No. 45, November 7, 2003, issue of the Florida Administrative Weekly. The changes have been made to the proposed rule to address comments made by the Joint Administrative Procedures Committee and to correct inadvertent errors in reference to forms contained in the rule.

Paragraph (4)(m) of Rule 25-30.445 is changed as follows:

(m) If the limited proceeding is being requested to change the current rate structure, provide a copy of all workpapers and calculations used to calculate requested rates and allocations between each customer class. The test year should be the most recent 12-month period. In addition, the following schedules, which are incorporated herein by reference, from Form PSC/ECR 19 (11/93), entitled "Class A Water and/or Wastewater Utilities

Financial, Rate and Engineering Minimum Filing Requirements",
should be provided. ~~—should be provided from the Class A Water~~
~~and/or Wastewater Utilities Accounting, Rate and Engineering~~
~~Minimum Filing Requirements (Form PSC/ECR 20 (11/93)).~~ The
schedules can be obtained from the Commission's Division of
Economic Regulation.

1. Schedule E-2, entitled "Revenue Schedule at Present and
Proposed Rates". ~~Revenue Schedule at Test Year Rates — Proof of~~

2. Schedule E-~~14~~ 12, entitled "Billing Analysis Schedules".
Only two copies are required.

STATEMENT OF CHANGES

Notice of the Commission's proposed adoption of Rule 25-30.445, F.A.C., appeared in the November 7, 2003, edition of the Florida Administrative Weekly. On December 8, 2003, the Commission received a letter from the staff of the Joint Administrative Procedures Committee (JAPC), containing comments on the proposed rule. Commission staff responded to JAPC's comments by letter dated December 12, 2003.

JAPC commented that subsection (4)(m) of proposed Rule 25-30.445 should include the title of the form and an explanation of how to obtain the schedules. The proposed rule was changed to more clearly identify the title of the form and to provide an explanation as to how to obtain the schedules incorporated by reference into the rule. Subsection (4)(m)1. was also changed to more clearly identify the title of Schedule E-2.

Also, upon review of the proposed rule, Commission staff realized that the rule inadvertently identifies Form PSC/ECR 20 as Form PSC/ECR 19. Thus, the proposed rule was changed to correctly identify Form PSC/ECR 20.

Also upon review of the proposed rule, Commission staff realized that it had inadvertently referred to Schedule E-14 as Schedule E-12 in the rule. Thus, the rule has been changed to reference Schedule E-14 and to more clearly identify the title of the schedule.
